Anonymous submissions or abstracts exceeding the word count are likely to be disqualified.

Scientific abstracts may be submitted for oral or poster presentation (category may be altered by the review committee).

Abstracts (max. 250 words) need to be structured under the following headings:

- Materials and Methods
- Results
- Conclusion

The submission will be scored on:

- Quality of scientific methods and conclusion
- Clinical relevance to BSIR
- Study design randomised controlled trials will score higher than prospective trials or retrospective case series
